

SliceUp, Inc. Beta Testing License Agreement.

SliceUp is a log parsing and analytics platform ("**Beta Software**"). As a tester you will receive from SliceUp software, documentation, or other materials (the "**SliceUp Materials**").

THE BETA SOFTWARE LICENSED HEREUNDER IS STILL IN TESTING PHASE AND IS PROVIDED ON AN "AS IS" AND "AS AVAILABLE" BASIS AND IS BELIEVED TO CONTAIN DEFECTS AND A PRIMARY PURPOSE OF THIS BETA TESTING LICENSE IS TO OBTAIN FEEDBACK ON SOFTWARE PERFORMANCE AND THE IDENTIFICATION OF DEFECTS. LICENSEE IS ADVISED TO SAFEGUARD IMPORTANT DATA, TO USE CAUTION AND NOT TO RELY IN ANY WAY ON THE CORRECT FUNCTIONING OR PERFORMANCE OF THE BETA SOFTWARE AND/OR ACCOMPANYING MATERIALS.

NOW, THEREFORE, in consideration of the mutual covenants set forth herein, the parties hereby agree as follows:

1. **Confidentiality.**
 - 1.1. Licensee agrees to keep confidential and not to transfer, copy, disclose, discuss, provide or otherwise make available in any form to any third party: a) The Beta Software and any of SliceUp Materials, b) SliceUp's performance and benchmarks, current stage of product development c) SliceUp development or marketing plans that you learn about as part of your participation as tester, d) Licensee's participation in the SliceUp Beta Program, and e) verbal or written communications from SliceUp employees, agents, contractors or other representatives regarding SliceUp Materials and the Beta Software. The confidentiality requirements continue until all of the above become publicly known, unless otherwise specifically provided herein or agreed by SliceUp in writing.
 - 1.2. This Beta Software can be accessible only to Licensees who are invited to test for using pre-release Beta Software and providing feedback to SliceUp. All information available concerning the Beta Software is confidential information of SliceUp. For a period of five years from the time Licensee accessed this confidential information, Licensee may not disclose this confidential information to any third party. This restriction will not apply to any information that is or becomes publicly available without a breach of this restriction; was lawfully known to the receiver of the information without an obligation to keep it confidential; is received from another source that can disclose it is lawfully and without an obligation to keep it confidential; or is independently developed. Licensee may disclose this confidential information if required to comply with a court order or other government demand that has the force of law. Before doing so, Licensee must seek the highest level of protection available and, give SliceUp prior notice as soon as possible to provide a reasonable chance to seek a protective order.
2. **No Conflicting Loyalty.** Licensee represents that neither Licensee nor any 3rd party that Licensee is acting on its behalf is: a) a member of the press or any public newsgroup, or b) an employee or representative of any competitor of SliceUp.

3. **Feedback.**

3.1. It is expressly understood, acknowledged and agreed that Licensee shall, regardless of whether or not formally requested to do, provide to SliceUp reasonable suggestions, comments and feedback regarding the Beta Software, including but not limited to usability, bug reports and test results (collectively, "Feedback"). If Licensee provides such Feedback to SliceUp, Licensee shall grant SliceUp the following worldwide, non-exclusive, perpetual, irrevocable, royalty free, fully paid up rights:

3.1.1. To make, use, copy, modify, sell, distribute, sub-license, and create derivative works of, the Feedback as part of any SliceUp product, technology, service, specification or other documentation (individually and collectively, "SliceUp Products");

3.1.2. To publicly perform or display, import, broadcast, transmit, distribute, license, offer to sell, and sell, rent, lease or lend copies of the Feedback (and derivative works thereof) as part of any SliceUp Product;

3.1.3. Solely with respect to Licensee's copyright and trade secret rights, to sublicense to third parties the foregoing rights, including the right to sublicense to further third parties;

3.1.4. To sublicense to third parties any claims of any patents owned or licensable by Licensee that are necessarily infringed by a third party product, technology or service that uses, interfaces, interoperates or communicates with the feedback or portion thereof incorporated into SliceUp Product, technology or service.

3.2. Further, Licensee warrants that its Feedback is not subject to any license terms that would purport to require SliceUp to comply with any additional obligations with respect to any SliceUp Products that incorporate any Feedback.

3.3. Should Licensee encounter any bugs, glitches, lack of functionality or other problems on the website, please let SliceUp know immediately so it can be rectified accordingly. Licensee can submit its requests and issues to basia@sliceup.co. Licensee's help in this regard is greatly appreciated.

4. **Grant of License to Test.** Subject to the terms and conditions of this Agreement, SliceUp hereby grants Licensee a personal, non-exclusive, non-transferable and revocable license (without the right to sublicense) to:

4.1. Use the Beta Software in accordance with, if any, the Documentation solely for purposes of internal testing and evaluation, and not for any commercial purpose or use;

4.2. Copy Beta Software for archival or backup purposes, provided that all titles and trademarks, copyright, and restricted rights notices are reproduced on such copies and provided that only one copy of the Beta Software may be used at a time.

5. **Restrictions on Grant.** Except as otherwise specifically permitted in this Agreement, Licensee may not:

5.1. Modify or create any derivative works of any Beta Software or documentation, including – without limitation – translation or localization; (code written to published APIs (Application programming interfaces) for the Beta Software shall not be deemed derivative works);

5.2. Copy the Beta Software except as provided in this Agreement or elsewhere by SliceUp;

- 5.3. Separate Beta Software, which is licensed as a single product, into its component parts;
 - 5.4. Reverse engineer, decompile, or disassemble or otherwise attempt to derive the source code of the Beta Software;
 - 5.5. Redistribute, encumber, sell, rent, lease, sublicense, use the Beta Software in a timesharing or service bureau arrangement, or otherwise transfer rights to any Software. Licensee may NOT transfer the Beta Software under any circumstances;
 - 5.6. Remove or alter any trademark, logo, copyright or other proprietary notices, legends, symbols or labels in the SliceUp Product(s);
 - 5.7. Publish or make public any results of benchmark tests run on any Software to a third party without SliceUp prior written consent.
6. **Support.** SliceUp is under no obligation i) to provide any technical support under the terms of this license, ii) to continue to develop, productize, support, repair, offer for sale or in any other way continue to provide or develop Beta Software either to Licensee or to any other party, and iii) provides no assurance that any specific errors or discrepancies in the Beta Software will be corrected.
7. **Ownership and Copyright of Beta Software.**
- 7.1. Title to SliceUp Materials and the Beta Software and all copies thereof remain with SliceUp. Licensee acknowledges and agrees that SliceUp and/or its suppliers own all right, title and interest in and to the Beta Software and in any and all intellectual property rights therein, including but not limited to any and all copyrights, patents, patent applications, trade secrets, trademarks and other intangible rights therein. The SliceUp Materials and Beta Software are copyrighted to SliceUp.
 - 7.2. Licensee will not remove copyright notices from the Beta Software and SliceUp Materials. Licensee agrees to prevent any unauthorized copying of the Beta Software and SliceUp Materials. Licensee agrees not to use SliceUp' trademarks or other business names for any purpose.
 - 7.3. SliceUp does not grant any express or implied right to Licensee under SliceUp patents, copyrights, trademarks, or trade secret information.
 - 7.4. Licensee will not earn or acquire any rights or licenses under any copyrights, patents, trade secrets, trademarks or other intellectual property rights on account of this Agreement or Licensee's performance under this Agreement.
 - 7.5. Licensee agrees to promptly disclose and hereby assign to SliceUp any suggestions for change and/or improvement to the Beta Software and SliceUp Materials and any related rights thereto and to assist SliceUp, as reasonably requested by SliceUp and at SliceUp' expense, in obtaining intellectual property protection relating to such suggestions as SliceUp may reasonably direct.
 - 7.6. Licensee further agrees, upon request of SliceUp, to remove any SliceUp Materials at the end of the Beta Software Program.
8. **Terms of This Agreement.**
- 8.1. Licensee's rights with respect to the Beta Software will terminate upon the earlier of: (i) the initial commercial release by SliceUp of a generally available version of the Beta Software; (ii) 3 months after the last date Licensee receives the Beta Software or any update thereto.

- 8.2. Either party may terminate this Agreement at any time for any reason or no reason by providing the other party advance written notice thereof. Upon any expiration or termination of this Agreement, the rights and licenses granted to Licensee under this Agreement shall immediately terminate, and Licensee shall immediately cease using, and will return to SliceUp (or, at SliceUp's request, destroy), the Beta Software, if any, the Documentation, and all other tangible items in Licensee's possession or control that are proprietary to or contain Confidential Information of SliceUp.
- 8.3. This Agreement will automatically terminate upon any breach by Licensee of any of Licensee's obligations hereunder including breach of confidentiality obligations. In such case Licensee shall immediately cease using, and will return to SliceUp (or, at SliceUp's request, destroy), the Beta Software, if any, the Documentation, and all other tangible items in Licensee's possession or control that are proprietary to or contain Confidential Information of SliceUp. Upon SliceUp's request, Licensee shall provide a proof of doing so.

9. DISCLAIMER OF WARRANTIES.

- 9.1. THE BETA SOFTWARE AND, IF ANY, DOCUMENTATION ARE LICENSED "AS IS", AND SLICEUP DISCLAIMS ANY AND ALL OTHER WARRANTIES OF ANY KIND, WHETHER EXPRESS OR IMPLIED, INCLUDING, WITHOUT LIMITATION, ANY IMPLIED WARRANTIES OF MERCHANTABILITY, SUITABILITY, USABILITY OR FITNESS FOR A PARTICULAR PURPOSE, MERCHANTABILITY, TITLE OR NON-INFRINGEMENT OF THIRD PARTY RIGHTS, TO THE EXTENT AUTHORIZED BY LAW.
 - 9.2. WITHOUT LIMITATION OF THE FOREGOING, SLICEUP EXPRESSLY DOES NOT WARRANT THAT THE BETA SOFTWARE WILL MEET LICENSEE'S REQUIREMENTS OR THAT OPERATION OF THE BETA SOFTWARE WILL BE UNINTERRUPTED OR ERROR FREE. THE BETA SOFTWARE IS BEING PROVIDED TO LICENSEE "AS IS" WITHOUT WARRANTY OF ANY KIND. LICENSEE ASSUMES ALL RESPONSIBILITY FOR SELECTING THE BETA SOFTWARE TO ACHIEVE ITS INTENDED RESULTS, AND FOR THE RESULTS OBTAINED FROM ITS USE OF THE BETA SOFTWARE. LICENSEE SHALL BEAR THE ENTIRE RISK AS TO THE QUALITY AND THE PERFORMANCE OF THE BETA SOFTWARE.
 - 9.3. LICENSEE FURTHER ACKNOWLEDGES AND AGREES THAT: (A) THE BETA SOFTWARE IS NOT COMPLETE IN DEVELOPMENT AND HAS NOT BEEN COMMERCIALY RELEASED FOR SALE BY SLICEUP; (B) THE BETA SOFTWARE HAS NOT PASSED ANY REQUIRED REGULATORY TESTS; (C) SLICEUP IS UNDER NO OBLIGATION TO RELEASE A COMMERCIAL VERSION OF THE BETA SOFTWARE; (D) SLICEUP HAS THE RIGHT TO UNILATERALLY ABANDON DEVELOPMENT OF THE BETA SOFTWARE AT ANY TIME AND WITHOUT ANY OBLIGATION OR LIABILITY TO LICENSEE OR ANY THIRD PARTY. LICENSEE FURTHER ACKNOWLEDGES THAT HE/SHE HAS PAID NO CONSIDERATION TO SLICEUP FOR THE BETA SOFTWARE HEREUNDER.
10. **Limitation of Liability.** TO THE EXTENT PERMITTED BY APPLICABLE LAW IN NO EVENT WILL SLICEUP BE LIABLE TO LICENSEE OR ANY PARTY FOR – WITHOUT LIMITATION – ANY LOSS OF USE; INTERRUPTION OF BUSINESS; OR ANY DIRECT; INDIRECT; SPECIAL; INCIDENTAL; EXEMPLARY OR PUNITIVE OR CONSEQUENTIAL DAMAGES OF ANY KIND (INCLUDING LOST PROFITS) REGARDLESS OF THE FORM OF ACTION WHETHER IN CONTRACT; TORT

(INCLUDING NEGLIGENCE); STRICT PRODUCT LIABILITY OR OTHERWISE; WHETHER ARISING OUT OF THE USE OR INABILITY TO USE THE BETA SOFTWARE (INCLUDING BUT NOT LIMITED TO LOSS OF DATA OR DATA BEING RENDERED INACCURATE OR LOSSES SUSTAINED BY LICENSEE OR THIRD PARTIES OR A FAILURE OF THE Beta Software TO OPERATE WITH ANY OTHER PROGRAMS), EVEN IF ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. THE PARTIES AGREE THAT THE FOREGOING LIMITATION OF LIABILITY IS MATERIAL TO THIS AGREEMENT.

11. **Privacy.** For purposes of this Beta Test Program, Licensee agrees to allow SliceUp, its employees or agents to contact Licensee using the personal contact information provided, such as name, email address, and telephone number. Any personal data collected will be a subject to our Privacy Policy available at <http://www.sliceup.co/privacypolicy>. SliceUp may store or share this personal contact information with SliceUp employees, agents or authorized contractors in order to communicate with you. SliceUp may use, collect, or store information generated from Licensee's testing and use of the SliceUp Beta Software and materials being provided to Licensee under this Agreement ("Usage Data"). SliceUp may disclose, share, redistribute, or publish such Usage Data. If Licensee is outside of the United States, Licensee understands and agrees that personal contact information and Usage Data will be transferred to the United States and stored on servers in the United States, subject to laws applicable in the United States.
12. **General Provisions.**
 - 12.1. **Governing Law and a Choice of Forum.** This Agreement shall be governed by and interpreted in accordance with the laws of the United States. Any claim or dispute arising in connection with this Agreement shall be resolved in the competent courts of the state of Delaware.
 - 12.2. This Agreement is a legal agreement and constitutes the complete and exclusive agreement between Licensee and SliceUp with respect to the subject matter hereof, and supersedes all prior or contemporaneous oral or written communications, proposals, representations, understandings, or agreements not specifically incorporated herein. This Agreement may not be amended except in a writing duly signed by Licensee and an authorized representative of SliceUp.
 - 12.3. If any provision of this Agreement is found to be invalid or unenforceable pursuant to judicial decree or decision, the remainder of this Agreement shall remain valid and enforceable according to its terms.
 - 12.4. You acknowledge that any breach of your obligations under this Agreement with respect to the proprietary rights of SliceUp will cause SliceUp irreparable injury for which there are inadequate remedies at law, and, therefore, SliceUp will be entitled to equitable relief in addition to all other remedies provided by this Agreement or available at law or in equity.
